Information about your planned gifts will remain strictly confidential. Should you wish to be listed in our Annual Report or be profiled in our communications materials, we will require your express written consent.

## Planned gifts can be tailor-made for the role you wish your legacy to play

**Unrestricted Gifts:** The best choice for those of you wishing to leave the creative process open to the care and discretion of the next generation at NTS. Your gift will be applied to the area of greatest need and/or emerging priorities.

Restricted Gifts: Allow NTS to plan ahead, thus providing critical support for designated areas such as Core Programs, Specialized Programs, Student Aid, Faculty Support, Equipment Renewal, and Library & Archives, to name but a few. Because each restricted bequest is unique, NTS encourages donors considering restricted gifts to speak with the Director of Development about the appropriate language.

**Expended Gifts:** These funds are used in their entirety, generally within a relatively short time frame. Some larger expendable gifts are used over longer periods. No minimum amount is required.

**Endowed Gifts:** Providing income every year in perpetuity, these funds carry out a designated purpose. Our endowed funds have minimum required amounts. Please speak the Director of Development if you are considering establishing an endowed fund.
